This is a contract between *The Furry Godmother* (hereinafter called "TFG" and the pet owner whose signature appears below (hereinafter called "Owner").

CONDITIONS OF BOARDING

- 1. All animals are to be 5 months or over and be fully vaccinated (C5 for Dogs and F3 for cats). Vaccinations must have been done at least 10 days prior to arrival
- 2. Entire female dogs must not be in season ("on heat"), or due to be in season during their stay.
- 3. TFG reserves the right to refuse entry of any animal without being required to give explanation.
- 4. A non-refundable boarding fee is payable at the time of booking for each animal. Long term boarders will pay monthly payments which shall be processed by credit card.
- 5. The full period booked will be charged in school holiday periods.
- 6. Boarding rates are charged on a calendar day basis.
- 7. The owner agrees to pay the rate for boarding in effect on the date the animal is checked in to TFG (as advised in the price list).
- 8. The owner agrees to pay all costs and charges for special services requested and any veterinary costs for the animal during the time the animal is in the Operator's care. In the event of the animal's serious illness and where the owner cannot be readily contacted the veterinary surgeon's decision in relation to treatment of the animal shall be final and conclusive.
- 9. The owner agrees to be solely responsible for any and all acts or behaviour of the animal while it is in TFG care and hereby indemnifies TFG and shall keep TFG indemnified to the full extent permitted by law for any action of the animal which apart from this indemnity may have created any liability on TFG.
- 10. The owner specifically represents that he or she is the sole owner of the animal, free and clear of all liens and encumbrances.
- 11. All charges incurred by the owner pursuant to this agreement must be paid before the animal leaves the TFG premises.
- 12. If all charges are not paid, TFG has the right to offer the animal for public sale or otherwise dispose of the animal in any manner which TFG may in its sole and absolute discretion deem appropriate. If such sale/disposal does not secure a price adequate to cover the charges and the cost of sale/disposal, the owner is liable to TFG for any shortfall. TFG may take this course of action as set out herein if not advised of a pick up date within two (2) weeks of the advised date at which time the animal will be deemed to be abandoned.
- 13. Under no circumstances will TFG, or its employees or agents, be held responsible for canine influenza, injury, death, loss or damage of any kind whatsoever that may occur to any animal while in the control of TFG.
- 14. By signing these conditions, the owner acknowledges their acceptance of the Conditions of Boarding Animal and certifies to the accuracy of all information given about the animal. The owner acknowledges that the signing of this contract shall create a lien over the animal in favour of TFG which lien shall continue to exist whilst ever monies are owing to the Operator pursuant to this agreement.
